

BCS Bedford Branch Chair report to AGM 17 September 2014

The last programme year has been a very busy and exciting year, with new initiatives connecting with the local schools, The National Museum of Computing, BioPark and other partners to further the interest of computing and IT in our area. Engaging members better is a recurring item in committee meetings and there are still a lot we are wanting to do.

1. Highlight of the year - Bedford BCS Challenge is our new venture to contribute to the school computing education in our area. The new Computing Curriculum that comes into force this month aims to teach children from the age of 5 to learn about programming and problem solving. BCS, through involvement in the Computing at School Working Group (CAS), has been a key force behind the movement. Bedford Branch set up a special project and worked with CAS and the Bedford Borough Council to set up an annual Bedford BCS Challenge for KS3 students. The results had been outstanding and the prize winners were presented with their awards in a special ceremony in Cranfield University. A half day meeting for computing/ICT teacher was held in The National Museum of Computing to foster network of teachers. We also supported a number of teachers to our July Family Fun Day.
2. Five new members joined the committee this year, including YPG representatives that we did not have for a long time. The new minds bought about new efforts in setting up meetings and social media. We were able to experiment with new meeting arrangements.
3. Successful series of joint meetings with Bedford College and other partners, sustaining high level of attendance.

BCS Treasurer work report to August 2014

Each year the biggest activity for the treasurer is the development of the bid for the following year's budget submission. This has to be prepared on the BCS spreadsheet and submitted by the end of March. The problems are:

- * one can only guess at the likely pattern of speakers, locations, dates and costs, yet the form is asking for the detailed expenditure under each of various headings and each in the column corresponding to the month.
- * Special events, such as our schools competition have to be included appropriately.
- * The whole has to include text justifying the various proposals.
- * This needs input from other members of the Branch Committee, obviously, and circulation to them for comments on the drafts as it is developed.

The allocated budget is not decided till about July, and for all the years I have been involved we and other branches have been allocated less than was bid for. Many other branches have for years bid high, typically in the ratio of 150 to 100, in the hope that their allocation will cover their expected expenditure.

We have to submit a supplementary bid on a different form to get further funding above the original allocation, with justification again. They will not accept a request that we be allocated the difference to make up our allocation to my original bid.

In most of the recent years we have had to cancel meetings or change them to cheaper locations that in many cases attracted fewer members to attend. In the meeting to allocate funding, they also compare the bid with the corresponding bid the previous year and what was finally actually spent. So if one reduces one's meetings and expenditure to fit the allocation, one is penalised the following year on the expectation that one will spend less than was allocated.

I do not agree with this behaviour, including that people who bid high etc and then spent their allocation were rewarded by the committee that allocates the available funds, eg getting enough in the following year. I feel that it would be far more realistic to bid for the best estimate that can be made in each March. Then any allocation short of the bid is a real signal from HQ that the funds are less than the bids and that we are being asked to reduce our planned meetings and events correspondingly. In some years we have been allocated a reduced sum that has to cover the first three months, Sept to Nov, say.

I have campaigned for many years to get the system changed, but for all these years except the last year my suggestions have been rejected. I wish that the system asked treasurers to submit their best estimate of everything and allowed the actual outturn to be slightly above or slightly below without penalty and without needing a supplementary bid if going over the allocation slightly.

Last year, the committee that allocates the money had a new chairman, and he has listened to what I have suggested and intends to gradually change things if he can. I had a long phone call with him last December.

Thus last December unexpectedly to us the committee allocated us more than my supplementary bid, so we have been able to run the schools completion and related event meetings with good meetings etc within that allocation. This was the first year that the outcome, eg of the subsequent supplementary bid and the allocated funding for the rest of the year, has not been a problem.

The rest of the role is:

- * to attend the various committee meetings, submitting reports if necessary in advance, or reporting that everything is satisfactory;
- * to keep records of what is committed, even though not spent yet;
- * to watch emails and at committee meetings for indications of things that are going to cause some expenditure, and to keep a record. This is now done by having an extra column or the right of the table of the proposed programme giving the best estimate of the expenditure as it all gradually evolves;
- * to get people who are planning meetings or events to find out the cost of hiring rooms and other likely costs, and to estimate the figures to be in that extra column;
- * to authorise payments, liaising was necessary;
- * generally to try to get the meetings and events to both not exceed the allocation, and also not be underspent against the allocation if possible;
- * report to the Member Group Committee when required;
- * prepare accounts for the Branch AGM.

In recent years we did not run anything that generated income for the BCS, so our bids did not have to include details that would be needed – eg if we were to run a conference say where the participants had to pay to attend. I have been involved in such things in the past but not recently.

The last few months, since 21st May 2014 have been exceptional as Pat was found to have cancer that could not be cured and I had to give up everything I was doing for the various organisations that I was involved in, so as to care for her full time. She continues to deteriorate, sadly. She is now in Airedale Nursing Home.

I am grateful to Fan particularly and other committee members for so excellently doing the job of treasurer during this difficult time.
